### Rules and Regulations Pertaining To Club Rental

\$100 Refundable Deposit Fee includes use of Club house and Grounds. The Deposit fee will be returned once inspection by a club officer is performed and is determined the facility is in order. You will also be required to make a \$50 Donation that will not be refunded. Please make two Checks out, one for \$100 Refundable and one \$50 donation out to the Ashtabula Rod And Gun Club.

#### Use of Clubhouse

This includes the exclusive use of the Clubhouse, porch, and kitchen along with tables and chairs. In addition the picnic tables, and Pavilion may be used.

All areas used must be left in a clean and re-usable condition. Cleaning must be complete prior to and not later than 11: 00 A.M. the following day. An additional fee may be assessed, if necessary, to cover "Clean up and or Vandalism."

Club rental does not include the use of the, Pond, Trap/Skeet range, Pistol Range, Indoor or Outdoor Archery Range or the Rifle Range.

#### Member Obligations

If you are having a function, you and/or your caterer must leave the area as you found it upon arrival. A private duty police officer (at the Member's expense) must be hired for any function with over a hundred people.

## **LIMITATION OF LIABILITY**

In consideration of the use of the facilities of Ashtabula Rod and Gun Club, the Member agrees to defend, indemnify and hold the Ashtabula Rod and Gun Club, its members, directors and officers harmless from and on account of any and all fault, liability, cost, expense, claim, demand or suit arising out of, related to or in any way connected with the use hereby authorized, or arising from the presence of any invitee or guest of the Member on the premises, including any claim for loss or injury to any of the guests or invitees of the Member or to their property. The foregoing indemnity shall include the reimbursement of the Club for reasonable attorneys fees and other costs of defense. The Member represents and warrants to the Ashtabula Rod and Gun Club, and intends thereby that the Ashtabula Rod and Gun Club shall rely thereon, and that neither the Member nor the Participants are relying upon any insurance which may be carried by the Ashtabula Rod and Gun Club.

The Member agrees to obtain all necessary permits and licenses, pay all fees and taxes relating to the Activity, and to comply with all applicable laws and regulations pertaining to the Activity and to the use of the Ashtabula Rod and Gun Club by the Participants.

The Member shall be liable to the Ashtabula Rod and Gun Club for any damage to property belonging to or in the custody of the Club or its members resulting from the negligent or intentional acts of any of the guests or invitees of the Member.

The Member understands and agrees that the Ashtabula Rod and Gun Club would not enter into this Agreement in the absence of the agreement of the Member to assume the risks herein described, grant the waivers and agree to the releases of liability provided herein; and the Ashtabula Rod and Gun Club is expressly relying on the foregoing assumption of risk, waivers, indemnities and releases by the Member.
